Position Title and Age Requirement: Head Lifeguard, 19 years old by June 1, 2022

Job's Time Frame: June 15-August 21, 2022

Compensation: \$200 flat rate for Staff Orientation and Training Week; Local staff: First year: \$250
Returning Staff: \$275, International staff: as per your visa sponsor agency's contract; room and board available for the entire Program, Support, and Day Camp Team as part of the compensation

Reports To: Day Camp Manager and Resident Camp Manager

Key Work Relationships: Lifeguards, fellow Program Staff (Adventure, Activity, Craft, Media)

Position Summary

The Head Lifeguard is responsible for running the waterfront activities including the pool, lake, and water slide. They schedule lifeguards for each waterfront activity every day. They serve campers from both Resident and Day Camp, which includes every age group. They may work weekend hours to guard for guest groups.

Key Job Functions

- Schedule lifeguards and guard with them at the pool, water slide, and lake
- Schedule lifeguards and guard with them at both Resident and Day Camp evening pool parties
- Explain, model, and give clear instructions to campers for appropriate waterfront behavior
- Conduct camper swim tests on Monday and keep track of the results
- Ensure camper safety at all times, fill out appropriate reports when needed
- Oversee and monitor the work of the lifeguards and mentor them
- Instruct counselors on how to assist in leading waterfront activities and ensure safety
- Keep waterfront areas clean and orderly every day and handle equipment and toys with care
- Oversee and enforce COVID-19 safety protocol according to CDC and Pennsylvania state guidelines
- Keep inventory of equipment and communicate needs promptly
- Participate in special events as needed including evening activities
- Learn and follow emergency protocol as needed
- Attend morning staff meetings and devotions every day
- Be in constant communication with the Camp Managers regarding daily schedules

Experience and Qualities

- American Red Cross Lifeguard or equivalent certification required
- Minimum two years of lifeguarding experience required
- Committed follower of Jesus Christ who submits to the Word of God
- Safety-oriented
- Effectively deal with emergency situations
- Organized and timely
- Flexible
- Responsible and reliable, demonstrates high level of integrity
- Independent, takes initiative
- Strong leadership skills, preferably with previous leadership experience
- Endurance and perseverance

Working Conditions and Physical Requirements

- Must be able to maintain leadership and emotional stability while completing tasks, sometimes with little sleep and under stress
- Ability to stay energized from early morning till evening maintaining a positive attitude
- Must be able to stand, sit and swim for extended periods of time, and be comfortable working in and around water
- Must maintain lifeguarding physical certification standards
- Must be able to use cleaning supplies
